City and County Joint Homeless Issues:

- The City and County are working to identify permanent supportive housing to replace the existing homeless camp located near Mana Soup Kitchen and the Tech Center. All agree that it is important to protect the general public from the danger of a wildfire, health and sanitation.
- The City, County and community have each agreed to contribute \$33,000 for a total of \$100,000 to fund a Homelessness Programs Coordinator position. This Coordinator serves as the primary point of contact for a wide variety of homeless issues. The Coordinator will collaborate with the staff from the City of Durango and La Plata County, various non-profit organizations, and other governmental jurisdictions to develop and coordinate a comprehensive and integrated approach to homelessness. San Juan Basin Public Health is being considered for providing office space and oversight for this position.
- The BOCC and City Council will hold a Joint Session to discuss the Homeless Issue further on Tuesday March 20 from 8:30-10:30am at the County Administration Building (CAB).

La Plata County Update:

- A lack of moisture has the county concerned about wildfires and weeds.
- There are just under 400 bears identified within the City limits this year. When bears are tranquilized in the city and then re-located out in ranching country, it becomes a concern for ranchers and farmers in the county.
- The La Plata West Water Authority is progressing on laying water pipe on the west side of the county.
- Lake Durango Water Authority came to an agreement to receive water from Lake Nighthorse with the ability to reach 1,817 taps. 550 new homes will need to be built in this area before we reach this capacity.
- The County is exploring the option of assisting to form a Sub-Sewer District in South Durango. The Animas
 Airpark needs sewer and it is the missing piece to commercial development in that area. The La Plata County
 Economic Development Alliance is looking for a grant for an alignment study to tie into South Durango Sewer
 District.

City of Durango Update:

- City Council re-enacted an Emergency Ordinance for the security and placement of residential and commercial wildlife trash containers to minimize human/wildlife conflicts. The Emergency Ordinance will end on May 4, 2018.
- Approximately 1,926.7 acres of land surrounding Lake Nighthorse which is owned by the Bureau of Reclamation was annexed into the City of Durango. The City is currently considering motorized use of the Lake.
- The City has been working towards an agreement which gives Housing Solutions the option to develop a 30-40 unit complex for low income housing using tax credits. This mirrors the VOA project in Three Springs last year which unfortunately did not move forward.
- Saturday April 21 from 11:00am-3:00pm on North Main Ave between 26th-30th Streets. The City of Durango and Business Improvement District are working together to re-brand the business district on North Main. Come celebrate the great businesses currently on North Main Avenue and see the future vision for the area.
- City of Durango <u>www.durangogov.org/engage</u> The City is asking for input from citizens to guide the future of Durango.
 - o They have identified \$2 million dollars in capital needs, particularly a new Police Station.
 - o They are selecting the artwork at the Hwy 160 and Hwy 550 intersection based on public input.
