#### **Durango City Manager Hiring Update**

- City Councilors on January 8th, 2020 met with the search firm Slavin Management Consulting to discuss desired criteria for the new City Manager's profile for recruiting purposes.
- Bob Slavin told the Council they would have a draft profile no later than January 20th. Once that is approved, the recruiting process will take no more than 90 days.
- Once a candidate is selected, it could be 30 to 45 days before the individual begins the position.

#### **Durango Creative District Update**

- A 2 year effort culminated in the official establishment of Durango's Creative District in December, 2019.
- Proponents say having a Creative District in Durango will allow increased access to capital and grants, increased promotion for local creative industries and regional Creative Districts, increased public benefit projects, and a shared vision for the creative community.

#### Plastic Bag Ban Update

- Durango Beyond Plastic (<u>https://www.facebook.com/Durangobeyondplastic/</u>) is proposing to ban single use plastic bags and impose a fee on paper bags in Durango.
- Leaders of the proposal have been collecting petition signatures and may ask the Durango City Council to consider an ordinance later this year.

# Southern Ute Tribe Updates

- The Southern Ute Indian Tribal Council has appointed Mrs. Kourtney Hadrick as the new Director of Energy for the Southern Ute Growth Fund. She began on January 6, 2020.
- Tribal Council is evaluating the status of the Southern Ute Detention Center. Rather than closing the facility, the Center will remain open while reviewing new solutions to offset operational expenses.

### Ignacio Utility Rates Update

- The Ignacio Board of Trustees will conduct a public hearing on Tuesday, January 21, 2020, at 6:30 p.m. in the Abel F. Atencio Community Room located at 570 Goddard Avenue in Ignacio, Colorado. The purpose of the hearing is to establish potential rates for water, sewer, gas and irrigation services for 2020.

### 2020 Census Update

- Census results help determine how billions of dollars in federal funding flow into states and communities each year. The population totals also determine the number of seats each state has in the House of Representatives. It's mandated by the U.S. Constitution: The U.S. has counted its population every 10 years since 1790.
- In December 2019, La Plata County adopted a resolution establishing a "Complete Count Committee" to enhance Census efforts. There are 25 people on the CCC, which is chaired by Tim Walsworth and Heather Otter.
- The Census begins this month in Alaska. By April 1, 2020, every home will receive an invitation to participate in the 2020 Census. Once the invitation arrives, you should respond for your home either online, by phone, or by mail.
