Legislative Advisory Coalition Update for March 9, 2021

Durango Financial Update

• Sales tax collections for the month of December were up 3.9% and up .05% year to date.

- Lodgers tax was down -18.9% for December and down -30.4% year to date.

Durango Strategic Plan

- City staff unveiled the 2021 Strategic Plan at the Durango Clty Council meeting March 2nd. The document lays out goals, strategies and desired outcomes with some time frames. Some of the goals listed include:
 - Implementing La Posta Partnership with stakeholders including La Plata County, La Plata Economic Development Alliance and property owner;
 - Developing a 10-year financial forecast for all funds to promote sound financial health;
 - Appropriating resources to ensure there is adequate city staff to focus on ways to increase affordable and workforce housing inventory through a variety of mechanisms that include land and or infrastructure acquisition (or bank), changes to code, and public-private incentives.
- City Manager Jose Madrigal noted the strategic plan is a starting off point and, once adopted, will be adjusted every year. A Study session is on March 9 at 3:30 pm and a final draft will be considered by City Council later this month.

LPEA Election

- LPEA members interested in running for a seat on the La Plata Electric Association (LPEA)
 Board of Directors now have access to the 2021 Board Director Candidate Packets at:
 http://www.lpea.coop/board-director-candidate-information.
- Directors are elected for three-year terms. Incumbent directors up for re-election are Kirsten Skeehan (District 1 – Archuleta County), Kohler McInnis (District 2 – South and West La Plata County), Britt Bassett (District 3 – City of Durango), and Tim Wheeler (District 4 – North and East La Plata County).
- Prospective candidates must return all completed materials by 1 p.m. on Monday, May 3, 2021 for consideration.
- To be eligible to run for the LPEA Board of Directors, candidates must:
 - be a member of LPEA for at least one year immediately prior to becoming a director;
 - be a bona fide resident of the district you plan to represent for at least 120 days prior to becoming a director and;
 - o not be employed by, or have a spouse or child employed by, LPEA in any position.
- The official ballot will be mailed to LPEA members in mid-May. Election results will be announced during a partial, virtual Annual Meeting on June 17, 2021.

Durango - La Plata County Airport

- Passenger traffic recovery at the Durango La Plata County Airport (DRO) continues to outpace the US average. Director of Aviation Tony VIcari said passenger traffic recovery at DRO has hovered between 50-60% of pre-pandemic levels for the past three months.
- American Airlines recently announced that it will establish seasonal service between Los Angeles International Airport (LAX) and DRO with one daily nonstop flight June 3 – August 16, 2021.
- Delta Airlines will operate one daily nonstop flight between Durango and Salt Lake beginning May 12. Beginning May 26, 2021, flight frequency will be increased to two daily departures and arrivals seven days per week.

LPC Projects Approved

- On Feb 16, 2021 the Board of County Commissioners approved the Paxton Preliminary Plat Subdivision and Class I Additional Dwelling Unit, a proposal for a 2 lot subdivision near Elmore's Corner and an additional dwelling unit.
- On Feb 18, the Joint Planning Commission approved a sketch plan for Elevation Park Phase 2 Subdivision and Phases 1 & 2 Multifamily. This is a Sketch Plan for a proposed subdivision of 12 single-family lots and 72 multi-family dwellings on 10.78 ac within Phase II and 14 multi-family dwellings on 0.749 ac within Phase I.

Durango Projects Approved

- On Feb 16, the Durango City Council approved the 150 E. 33rd Street Preliminary Minor Subdivision & 3215 E. 2nd Avenue Preliminary Minor Subdivision, creating 6 parcels in total.
- On Feb 22, the Durango Planning Commission approved the Rosemary Lane Preliminary Development Plan (157 Rosemary Lane), which will include 16 single family lots and ADU's on all properties.
