Legislative Advisory Coalition Update for April 13, 2021

### **County Oil & Gas Regulations**

- The La Plata County Board of County Commissioners is preparing for the creation of new oil and gas regulations (Chapter 90) in the Land Use Code
- Staff is planning a process that includes presentation of the Table of contents, technical work groups, public meetings, and work sessions with the BOCC and the Planning Commission.
- At 2 pm on April 13, the Colorado Oil and Gas Conservation Commission will hold a joint work session with the BOCC for a deep dive into SB 181, which replaces 16 existing statutes, reallocates authority, rejects preemption of local government regulations and fundamentally changed the mission of the COGCC.

## **Durango City Election**

- Olivier Bosmans and Jessica Buell were elected to the City Council, replacing Chris Bettin and Dean Brookie.
- Melissa Youssef retained her seat on City Council.
- New councilors will be sworn in on April 20.
- Ballot Issue 1A, raising the Lodgers Tax to 5.25%, passed. It becomes effective on June 1, 2021.

## **Durango Financial Update**

- Sales tax in January was up 4.8% for the month.
- Lodgers tax was down -26.1% for the month of January.

## La Plata County Financial Update

- Sales tax collections for January show an increase of \$71,789 or 4.61% in comparison to the same period in 2019. Year to date, Sales tax has increased \$2,344,429 or 14.14% over the same period in 2019.
- Lodger's tax collections for Quarter 3 show an increase of \$69,543 or 40.87% from the same period in 2019. Year to date for 2020 is an increase of 60,262 or 16.74%, over the same period in 2019.

## LPC Projects Approved

- On March 16, the BOCC approved The Timbers at Edgemont Highlands Phase 3D Final Plat, a subdivision for 25 single family lots and 12.07 acres of open space on 38.054 acres on the east side of Edgemont Highlands.
- On March 11, the LPC Planning Commission approved a Preliminary Development Plan to resubdivide Area D of Glacier Cliff lots 13 to 17 to create 2 additional lots, 7 lots total.
- On March 11, the LPC Planning Commission approved a Sketch Plan for 13 duplexes resulting in 26 total units built in several phases on 3.2 acres on Tacoma Dr.
- On March 25, the LPC Planning Commission approved a Sketch Plan to construct a 4,000sq.ft structure for use in association with the existing commercial business known as the Fun Center.
- On March 25, the LPC Planning Commission approved a Sketch Plan for a proposal to subdivide 35.82 acres into 6 single family lots ranging between 4 to 8 acres in size on CR 516 just outside of Bayfield.
- On April 8, the LPC Planning Commission approved a Sketch Plan for an approximately 6,800sq.ft. marijuana cultivation facility located on US 550 S within the Florida Mesa Planning District. No retail sales or distribution is proposed on site.

### **Durango Projects Approved**

- On March 16, the Durango City Council approved a request from Jake Lavin for a Preliminary Development Plan for a 2.4 acre property located along the western portion of Rosemary Lane. The proposal is for a 16-unit single family residential development. All 16 homes will include the potential for integrated Accessory Dwelling Units.
- On March 22, the Durango Planning Commission approved a Conceptual Development Plan approval for a commercial building and tiny home community at Mild 2 Wild on the north side of Durango.
- On March 22, the Durango Planning Commission approved the Mountain Trace II and Timber Trails Preliminary Development Plan. The Mountain Trace II development will include 18 townhomes located in 3 buildings along the south and west side of Metz Lane, adjacent and connected to the existing Mountain Trace 1 development. Timber Trails will be 23 single family homes built to the north and east side of Metz Lane.
- On March 22, the Durango Planning Commission approved a proposal for a subdivision for the Best Western Inn & Suites on Hwy 160 West. The owner, Scott Brunvand, has applied to subdivide the lot into two separate lots. Of the new lots, one would contain what is now the lodging portion of the property and the other would contain the restaurant.
