Legislative Advisory Coalition Update for May 11, 2021

## **American Recovery Plan**

 The City of Durango is slated to receive \$4.07 Million dollars in American Recovery Act funds. The city will receive the first half of the funding in May and the rest 12 months later.

- At a study session on April 13, Durango City Councilors expressed an interest in using the funds for economic development and infrastructure such as for La Posta Road and infrastructure for Durango Mesa Park. They also discussed supporting the creation of housing.
- City staff will bring recommendations back to council in the near future.

## **Durango Financial Update**

- Sales tax in January was up 11.5% for the month.
- Lodgers tax was down -26.1% for the month of January.

#### **Durango La Plata County Airport Update**

- Tony Vicari, Director of Aviation, told the Durango Clty Council on May 4 that the airport is seeing recovery this spring.
- Traffic decreased 49% in 2020 over 2019 but in Q1 of 2021, traffic has improved to approximately 70% of 2019 levels, with March exceeding 80% recovery.
- Passenger traffic recovery at DRO has consistently outpaced the US average since summer 2020. The final March 2021 TSA throughput figure of 83% of 2019 levels at DRO remained well above the US average of 52% for the same period. Through mid-April, TSA throughput at DRO has crested 90% of pre-pandemic levels.
- Airline seat capacity has recovered to over 90% of pre-pandemic levels through March 2021. Looking ahead to the summer, June 2021 airline seat capacity is forecast to exceed 2019 levels by over 15%.

#### **Multiplexes and Accessory Dwelling Units**

- The Durango Planning Staff is moving toward legalizing and making safe multiplexes in Durango.
- Multiplexes are typically single-family houses that have been split into three or more apartments. They are not legal, but they provide housing.
- According to a Community Development Department Memo: Our goal is to find the right
  mix of incentives and regulation to keep these important sources of housing in operation
  while ensuring any needed safety improvements are made. If the regulations are too
  severe, owners are discouraged from coming forward and we lose the opportunity to
  make safety improvements.
- Planning Staff is also considering making changes to the Accessory Dwelling Unit (ADU) program. Staff has heard suggestions such as: they need to allow some types of

- alternative compliance requests, especially for the principal structures; they should consider eliminating or reducing lot size restrictions; and they should allow detached ADUs in EN-4 zone district on large lots, among other things.

## **Fire Restrictions Authority**

- La Plata County Commissioners have given the County Sheriff the authority to enact fire restrictions.
- Previously, enacting fire restrictions requires a public hearing and an ordinance.
- County Sheriff Sean Smith told the Board the proposed changes would be simpler and save time.
- Under the changes, a science-based checklist would be used to help the Sheriff determine
  the need for fire restrictions and the level of restrictions. The changes would also mean
  automatic restrictions on declared Red Flag Days.
