Legislative Advisory Coalition Update for September 8, 2020

Durango Hiring Update

- At the September 4, 2020 Special Meeting, Durango City Council voted to approve the employment contract to hire Jose Madrigal as the City Manager. Madrigal will start September 14th at a salary of \$210,000.00 per year.
- At the August 25, 2020 Study Session, Interim City Manager Amber Blake said she will pause
 the search for a new Finance Director. Amber said she will move forward in selecting finalists
 but will leave the final choice to the new City Manager.

Durango Homeless Camp Update

- Durango City Council directed staff to draft a lease for a managed, homeless transitional camp near Greenmount Cemetery.
- The lease will be introduced at the next City Council regular meeting on September 15th.

Durango Financial Update

- Sales Tax in July was down 5.9% and down 4.9% year to date.
- Lodgers Tax in July was down 51.4% and down 43.7% year to date.

Land Use Code Update

- On August 20, 2020, the La Plata County Board of County Commissioners gave direction to staff for the 3rd and final draft of the Land Use Code.

- The BOCC will consider adoption of the draft Code on Tuesday, September 15 at noon.

Once adopted, the new Code would likely become effective early or mid October.

LPC Financial Update

- Sales tax collections for July show an increase of 11.45% in comparison to the same period in 2019. Year to date, Sales tax has increased 17.02% over the same period in 2019.
- Lodger's tax collections for Quarter 1 show a decrease of -18.05% from the same period in 2019.
- Highway User's tax payments for June 2020 are down by -39.02% compared to the same period in 2019. Year to date, Highway Users Tax is down by -16.71% over the same period in 2019.

Durango Projects Approved

- On August 24, the Durango Planning Commission approved the Larkin Minor Subdivision Preliminary Plan, Abandonment and Rezone. The owners proposed purchasing adjacent property from the Durango & Silverton Narrow Gauge Railroad and combining it with their existing lot.
- On August 24, the Durango Planning Commission approved the Maverik at Southfork Gateway Preliminary Plan. SEH Incorporated plans to construct a new gas station and convenience store in the Southfork area, just west of Three Springs.

La Plata County Projects Approved

- On August 18, the BOCC approved the Kroeger RV Park Class II, a 19 space RV park with office and laundry services.
- On September 1, the BOCC approved the Grigsby Subdivision Preliminary Plat and Final Plat. This is a subdivision of a 3.14-acre tract into 3 single family lots of 1.497, 0.829 and 0.812 acres located 124 Wild Rose Ln.
