Plastic Bag Ban Update

- A large crowd filled Durango City Hall on November 19th to protest against single use plastic bags and encourage the use of reusable cloth bags.
- Leaders of the proposal have been collecting petition signatures and may ask the City Council this spring to consider an ordinance to ban single use plastic bags.

Durango City Manager Hiring Update

- City Councilors on November 19th selected the search firm Slavin Management Consulting to find candidates for a new Durango City Manager.
- During the interviewing process Bob Slavin told the Council they could expect about 10 to 15 vetted, qualified candidates to come out of the search process.

Four candidates are competing for two seats on the Southern Ute Tribal Council. The candidates are former chairman James Olguin, former council member Ramona Eagle, incumbent Adam Red, and tribal employee Marjorie Barry. Town of Ignacio Election Update

- Three Town of Ignacio Trustee seats are up for election on April 7, 2020.
- Nomination packets are available from Town Hall on or after January 7, 2020.
- In order to qualify as a candidate, you must: be eighteen (18) years of age by April 7, 2020; have resided in the Town of Ignacio for the 12 months immediately preceding April 7, 2020; be a registered elector in Precinct 24; complete the nomination petition and obtain a minimum of ten (10) valid signatures of registered electors from within the Town.
- These petitions must be turned into the Town Clerk by end of business day on January 27, 2020.

Bayfield Planning Commission Opening

- The Board of Trustees for the Town of Bayfield is seeking a qualified resident to volunteer to fill a vacant seat on the Planning Commission.
- Qualifications for the seat include residency in the Town of Bayfield. There is typically one meeting per month, on the second Tuesday of each month. The appointment is for a four (4) year term.
