Legislative Affairs Coalition Update for June 8, 2021

#### **American Recovery Plan Act (ARPA)**

- The City of Durango is slated to receive more than \$4M in ARPA funds.
- The money can be spent on:
  - COVID-19 expenditures or negative economic impacts of COVID-19, including assistance to small businesses, households, hard-hit industries, and economic recovery.
  - Premium pay for essential workers.
  - Investments in water, sewer, and broadband infrastructure.
- At a study session on May 25th, City staff recommended
  - \$1.5m be used to extend water service south along La Posta Road
  - \$300K be used to support attainable housing with staffing, equipment and office space.

#### Durango La Plata County Airport Update

- Director of Aviation Tony Vicari told the La Plata Board of County Commissioners the airport will emerge from the pandemic stronger than it was before.
- YTD, 2021 traffic has recovered to approximately 73% of 2019 levels at DRO, with both March and April exceeding 80% recovery.
- Passenger traffic recovery at DRO has consistently outpaced the US average since the onset of the pandemic.
- Airline seat capacity has recovered to 95% of pre-pandemic levels through April 2021.
- Looking ahead to the summer, June 2021 airline seat capacity is forecast to exceed 2019 levels by over 15%.

#### **Durango Financial Update**

- March sales tax was at 23% and 15% for the year. See the Tax Snapshot for March here: <u>https://www.durangogov.org/DocumentCenter/View/20148/March-2021-Sales-Tax-Snapshot-PDF</u>
- February sales tax was at 10%. See the Tax Snapshot for February here: <u>https://www.durangogov.org/DocumentCenter/View/20027/February-2021-Sales-Tax-Snapshot-PDF</u>
- Lodgers tax was at -2% in March, -39% in February.
- Staff said the numbers are a snapshot in time and not comparative year to year.

#### **Downtown Durango Update**

- A City Order was signed Tuesday, May 18 to temporarily reduce the speed limit to 15 miles per hour along the 500-1200 blocks of Main Avenue in downtown Durango.
- The reduced speed limit will be in effect until October 31, 2021, when the bump-outs are set to be removed.

### LPC Vacation Rentals Update

- La Plata County Staff is moving in the direction of bringing to the board a proposal to enact a business licensing program for short term rentals, probably in the 3rd quarter.
- The county contracted with Lodging Revs to get a handle on how many rentals are out there. Lodging Revs has found over 800, mostly houses along with rooms for rent.
- Deputy County Manager Mike Segrest said it's not just about collecting money, it's also about making sure there are not untoward impacts on neighborhoods.
- When the program starts, there will likely be an advisory letter notifying property owners they are supposed to have a business license.

- HB21-1271 <u>https://leg.colorado.gov/bills/hb21-1271</u> Concerning the establishment of programs offering state assistance to local governments to promote the development of innovative affordable housing strategies in a manner that is compatible with best local land use practices, and, in connection therewith, making an appropriation was assigned to the Committee of the Whole.

### **Durango Projects Approved**

- On 5/24/21, the Durango Planning Commission approved the Boxcar Landing Conceptual Planned Development. This is for a mixed-use project on Main Avenue on the north side of Durango. The project would contain 162 units, with one and two-bedroom apartments rented at market rate. The project will be heard before Durango City Council in mid June.
- On 5/24/21, the Durango PC approved the Crader Lot 5 Preliminary Development Plan, which includes subdivision, for the 16.9-acre property south of Wilson Gulch Road, north of the traffic circle. The proposal is to create 5 developable lots of varying sizes and install the initial infrastructure to service future development of the lots. The project will be heard before Durango City Council in June.

• La Plata Planning Commission approved the Buffalo Arena temporary use permit. The permit allows Kim Crader Buffalo to hold equestrian events May 29th through September 25th, 2021 on a 65 acre site on High Lama Lane.
